TERMS AND CONDITIONS

1. The quotation opening authority reserves the right to accept or reject any offer without assigning any reason there to.
2. The validity of the quotation should be for at least six months from the date of opening of the quotation.
3. Quotation shall be accompanied with the CDR equivalent to the 2% of the total contract value from any Nationalized bank of India pledged to the Chairman, Sainthia Municipality without which the quotation will be rejected.
4. The delivery & installation period should be clearly mentioned in the offer and should be to 8 weeks.
5. Subject to the availability of the funds 85% of the payment shall be made after receiving the delivery and successful commissioning and remaining 15% payment shall be released after inspection at our works.
6. The supply is to be made FOR Sainthia Municipality head office at Sainthia, Birbhum.
7. Tentative specifications are given on the enclosed annexure (A).
8. The supply shall be guaranteed / warranted for a period of at least ONE year against any manufacturing defect. The firm shall be responsible for any replacement/ repairs during the warranty period free of cost and within shortest possible time
9. The successful quotationers shall have to execute an agreement with the authorities of the Sainthia Municipality on a proper judicial paper within a period of 7 days after receiving the supply or

10. Any dispute arising between the successful quotation and the Sainthia Municipality the decision of the Chairman, Sainthia Municipality shall be final and binding upon the parties.
11. The rates shall be inclusive of all taxes including transportation charges state entry tax, VAT, and any other tax permissible under rules.
12. Latest VAT / sales tax clearance certificate is to be produced along with the offer.
13. All the material and workmanship shall be of the best quality and specifications. All equipments fitted shall be brand new.
14. Force Majeure: - Should the dispatch, installation, testing and commissioning of the work be delayed by strikes, lockouts, fire, accident, flood, war, natural calamities or any other cause beyond the control of the firm and the firm shall certify the Corporation in this respect by a documentary proof, reasonable extension of time for delivery of the machines and its system may be granted by the Municipality.

The Municipality shall at any time have access to the works and to the site where the fabrication is being taken in hand and where material /manufactured articles and machinery, are being obtained and to inspect and examine material and workman ship and to make the test of the system during its manufacturing.
16. In case of any dispute arising between supplier and Municipality, the courts of Suri, West Bengal State shall have the only jurisdiction.
17. In case the supplier fails to implement the supplies as per supply order, the CDR/FDR of the supplier shall be stand forfeited and alternative arrangement be made at the risk and cost of the supplier.
